PROPOSAL #3 - Implement Post Season Roll-Up Plan	CIRCLE CHOICE
Roll-up only occurs within the same district/region for injury, illness, eligibility, scratch, etc.; if alternate is no available, spot becomes a bye	Current
Option A: Adopt roll-up plan as follows Region: 5th place in same District, 6th place in same District, 5th place in opposite District, 6th place in opposite District State: 5th place in same Region, 5th place from another Region as determined by random drawn rotating roll-up plan	Option A
Option B: Roll-up plan as outlined in Option A, but allow any open spot in a bracket to be filled by roll-up no matter the reason for opening (including weight)	Option B

PROPOSAL #4 - Seeding Process	CIRCLE CHOICE
<p>A: State Duals - Region champs #1 seeds in four pools (coaches can discuss replacement prior to draw if injury, illness, etc affect a #1 and majority agree on change) and blind draw will determine pool assignments</p>	<p>Yes or No</p>
<p>B: District - implement consistent process for seeding the district tournament: seed top four individuals (max one per team) with remainder of the bracket set via a blind draw which evenly distributes byes and separates A/B wrestlers from the same team</p>	<p>Yes or No</p>

PROPOSAL #5 - Fees	CIRCLE CHOICE
<p>A: KSWA Sanctioned Event Host Fee - along with bylaw acknowledgement form, KSWA must receive event sanction form and host fee of \$180 from each District and Region host by December 15; failure to comply may result in change of venue for the event</p>	<p>Yes or No</p>
